I (We) authorize any person having information as to the above named firm to release financial information and credit reports to Rasa Floors & Carpet Cleaning, known as "RASA". It is further agreed and understood that all accounts or monies due Rasa shall be due and past due and payable at its office in Carrollton, Texas; that all past due accounts, notes or judgments shall bear interest from the date the indebtedness is first incurred until paid at the maximum rate allowed by law. If the account or notes are placed with an attorney for collection, the debtor and his guarantors, if any, are liable for all reasonable attorney's fees and costs incurred in the collection of the indebtedness. We agree to pay interest at 18% per annum on all invoices not paid within 30 days from the invoice date if Rasa must take action to collect its monies, such as sending a demand letter and/or subsequently filing a mechanic's lien then Rasa may administer a \$650 administrative fee to cover its costs of time and money, along with any and all attorney's fees, finance charges, and interests involved in collecting any and all monies owed to Rasa. If any legal proceedings are brought to enforce the provisions of this Agreement, it is expressly agreed by the parties that venue shall be in Collin County, Texas.</p>
